# **Continued Call for Water Conservation**

New issues have arisen in the water supply network, and customers of the Placer County Water Agency and the Nevada Irrigation District will need to practice their water conservation into 2025. Since our plant receives its untreated raw water from PCWA, that means conservation in Christian Valley Park, as well.

The two water agencies, PCWA and NID, said that while work continues to progress along two PG&E pipelines that were damaged from winter storms, a new problem occurred at Lake Spaulding.

As operators of one of the Spaulding powerhouses turned on the generator for testing, unforeseen mechanical failures occurred that created a major delay in the return of regular water flows along the system.

PG&E now estimates that with the additional repairs needed at Lake Spaulding, along with the continued work required on the Drum Canal, the earliest they expect water services to return to normal is summer 2025.

As the water demand from the reservoir continues to be far higher than the amount of water flowing in, we ask that everyone continue doing their best to conserve water where they can.

#### Fire Code and Burn Day Adherence

With autumn comes burning, and with burning comes a need to provide information on how to conduct legal outdoor burns.

Burning is only allowed on "permissive-burn days," regardless of whether it requires an APCD Burn Permit or not. Those wishing to burn must call 530-889-6868 or check the online burn day information each day to obtain the "Burn Day and No-Burn Day" information prior to igniting an outdoor fire. The "No-Burn" status is called either as a result of poor air quality conditions or due to hazardous fire conditions.

#### **Drive Safely**

Christian Valley Park, CSD, is a residential area and the speed limit for residential areas is 25 mph. California Vehicle Code Section 22358.3 establishes the 25 mph speed limit in residential areas in California. This section states that the 25 mph speed limit is a prima facie speed limit in residential areas, business districts, and public parks.
